Sub: Notice under Section 80, Code of Civil Procedure – reg.

This is regarding a notice received from Shri Rajiv Bahl, Economic Officer in this Directorate under Section 80, Code of Civil Procedure. Section 80 of the Code provides that no suit shall be instituted against the Government or against a Public Officer in respect of any act purporting to be done by such public officer in his official capacity until the expiration of 2 months next after notice in writing has been delivered.

2. Through this notice Shri Bahl has requested for withdrawal of the action taken as per Memorandum dated 30.09.2019 for not attending office as per the office timings.

3. The genesis of the case goes back to September, 2019 when upon random scrutiny of attendance on Biometric Attendance System (BAS), it was observed, as per directive of Hon'ble Agriculture Minister, that Shri Bahl was not available in Office during Office timings. Accordingly a memo was issued seeking his explanation in the matter. As his reply was evasive, he was again asked to submit his explanation in the matter. Both the memorandums vis a vis his replies are attached.

3. On thorough examination of the electronic records of BAS vis a vis replies submitted by Shri Bahl, it was found that the explanation of the applicant was found to be without cogent reasons, accordingly 71 days of Earned leaves were been deducted from his leave account as per DoPT's OM No. 11013/9/2014-Estt(A-III) dated 21.11.2014 and 22.06.2015.

4. It may be seen that on the basis of the position explained above that deduction of leaves for the dates on which Shri Bahl was not available in the office during office hours is as per the extant instructions on the subject issued by DoPT read with edict of Hon'ble Agriculture Minister.

5. Hence, no further action may be required on the notice of Shri Bahl as the deduction of leaves is in accordance with laid down procedure.


