The Government of India fixes Minimum Support Price (MSP) for 22 mandated agricultural crops viz. paddy, jowar, bajra, maize, ragi, arhar, moong, urad, groundnut, soybean, sunflower, sesamum, nigerseed, cotton, wheat, barley, gram, masur (lentil), rapeseed/mustard, safflower, jute and copra and Fair & Remunerative Price (FRP) for sugarcane on the basis of the recommendations of the Commission for Agricultural Costs & Prices (CACP), views of State Governments and Central Ministries/ Departments concerned and other relevant factors. In addition, MSP for toria and de-husked coconut are fixed on the basis of MSPs of rapeseed/mustard and copra respectively. MSP of copra for the last ten years is given in the table below:
