(1) On the basis of above mentioned facts, kindly explain that if M.I.Unit Delhi had become non-functional in 2004 and there is also no scope of M.I.Unit Delhi becoming functional in near future (as informed vide reply dated 14/11/2014), then why the said notification (issued in 2012) stated that initial posting will be in


