In so far as this Directorate is concerned with regard to fixation of Minimum Support Prices (MSPs) of mandated crops, it is be stated that Government fixes minimum support prices (MSPs) of 22 mandated agricultural crops viz, Wheat, Paddy, Maize, Jowar, Bajra, Ragi, Barley, Arhar (Tur), Moong, Urad, Gram, Masur, Groundnut, Rapeseed/Mustard, Soybean Sesamum, Sunflower seed, Safflower, Nigerseed, Cotton, Jute, Copra and fair & remunerative price (FRP) for sugarcane on the basis of recommendations of the Commission for Agricultural Costs & Prices (CACP). In addition, MSP for Toria and de-husked coconut is also fixed on the basis of MSPs of rapeseed/mustard and Copra respectively. While recommending MSPs, the CACP considers important factors like cost of production, overall demand-supply conditions, domestic and international prices, inter-crop price parity, terms of trade between agricultural and non-agricultural sectors, the likely effect on the rest of the economy, besides ensuring rational utilization of productive resources like land and water.

MSP determination of agricultural commodities is a policy issue and is not done under any act of Parliament.

I am directed to refer to your RTI application dated 14.08.2019 seeking information under Right to Information Act 2005 on the subject mentioned above.

In this regard it may be stated that Government fixes minimum support prices (MSPs) of 22 mandated agricultural crops viz, Wheat, Paddy, Maize, Jowar, Bajra, Ragi, Barley, Arhar (Tur), Moong, Urad, Gram, Masur, Groundnut, Rapeseed/Mustard, Soybean Sesamum, Sunflower seed, Safflower, Nigerseed, Cotton, Jute, Copra and fair & remunerative price (FRP) for sugarcane on the basis of recommendations of the Commission for Agricultural Costs & Prices (CACP). In addition, MSP for toria and de-husked coconut is also fixed on the basis of MSPs of rapeseed/mustard and Copra respectively. While recommending MSPs, the CACP considers important factors like cost of production, overall demand-supply conditions, domestic and international prices, inter-crop price parity, terms of trade between agricultural and non-agricultural sectors, the likely effect on the rest of the economy, besides ensuring rational utilization of productive resources like land and water.

CACP while recommending MSP takes into account both A2+FL (All paid out costs and imputed value of family labor) as well as C2 costs. However so far as returns over cost is concerned, CACP uses only A2+FL costs and uses C2 cost as a benchmark for considering whether the recommended MSPs cover these costs at least in some States as far as possible.
