Cultivable / Agricultural Land includes Land under Miscellaneous tree, Culturable waste land, Fallow Lands other than current fallows, Current fallows and Net area Sown. The information sought by applicant on agricultural land (latest available) in the country is available in the Directorate's annual publication titled as "Land Use Statistics At A Glance" having All India data since 1950-51. The publication is uploaded on the Directorate's website (http://eands.dacnet.nic.in) and may be accessed with the path LUS (State) > Latest LUS State Data> All India Summary Tables.
