

Sir,

I am directed to refer to your RTI Application dated 15.05.2018 seeking information under RTI Act, 2005 regarding delay in the process of providing Minimum Support Price(MSP) and other financial assistance to farmers.

In this context, it is informed that MSPs are announced by the Government well before the beginning of the sowing season of rabi and kharif crops on the basis of the recommendations of the Commission for Agricultural Costs and Prices(CACP). Government fixes MSP to protect the farmers from distress sale and offers to procure their crops when prices fall below MSP. However, farmers have the option to sell their produce to the government agencies or in the open market whichever is advantageous to them.


