The appeal filed by Shri Santosh Shere, under RTI Act, 2005 came up for hearing before me on 18.03.2015.

- 2. The CPIO submitted that the applicant requested for information vide RTI Request Regn. No. DOA&C/R/2015/60035 dated 24.01.2015 on Maharashtra State District wise & Total Crop wise Area, Production & Productivity from 2004 to till 2015.
- Directorate of Economics and Statistics (DES) is compiling and disseminating District-wise data on area, production and yield (productivity) of around 42 major crops based on the data supplied by the designated State Agricultural Statistics Authorities (SASA). The information has been uploaded in the web site of the Directorate from time to time for all the states. The applicant was informed accordingly and the URL of the website "http://eands.dacnet.nic.in" was also provided through Directorate letter F. No. 7-1/2014(RTI))-SDDS-ES dated 13th Feb, 2015. For instant access to the information available in Ministry, this please refer "http://apy.dacnet.nic.in/crop_fryr_toyr.aspx". However, data on these in respect of the State of Maharashtra is available with the Ministry upto 2010-11 only. Beyond that period data in respect of the above may be available with the concerned department of the State Government of Maharashtra.
- 4. DES also compiles estimates of area, production and yield at State & National levels in respect of major crops only. Information available with the Ministry in this regard in respect of Maharashtra was also provided to the applicant vide letter No.2-9/2015/-AS(E)-ES dated 19th Feb, 2015.
- 5. The applicant filed the present appeal seeking information Crop-wise and District-wise for all fruits, vegetables, Spices & Condiments, pulses, Cereal crop etc in Maharashtra from 2004 till date.
- 6. District-wise information for all agricultural products may be available with the State authorities concerned. The applicant is requested to contact the concerned department of the State Government of Maharashtra for the requisite information.
- The appeal is disposed off.
