OFFICE MEMORANDUM

Subject- Fixation of Minimum Support Price (MSP) for procurement of mature de-husked coconut for 2023 crop season-reg.

The undersigned is directed to refer to Economic and Statistics Division's letter No. 18-1/2022-CC-ES dated 30th December, 2022 conveying the decision of Government of India for fixing Minimum Support Price (MSP) for FAQ variety of Milling Copra at Rs. 10860/- per quintal for 2023 crop season.

2. It has been decided with the approval of the Competent Authority to fix the MSP of mature de-husked coconut at the rate of Rs. 2930/- per quintal for the crop season 2023 based on the MSP of FAQ variety of Milling Copra for 2023 season.

3. National Agricultural Cooperative Marketing Federation of India Limited (NAFED) and National Cooperative Consumers' Federation of India Limited (NCCF) will continue to act as the Central Agencies to undertake price support operations for procurement of mature de-husked coconut at the Minimum Support Price in the coconut growing States.

4. The terms and conditions for procurement of mature de-husked coconut at MSP will be the same as for procurement of FAQ variety of Milling Copra at MSP as per O.M. ibid.

5. Appropriate action may be taken by the concerned Ministries/Departments, States Governments and other agencies.
