The Government of India fixes Minimum Support Price (MSP) for 22 mandated agricultural crops viz. paddy, jowar, bajra, maize, ragi, arhar, moong, urad, groundnut, soyabean, sunflower, sesamum, nigerseed, cotton, wheat, barley, gram, masur (lentil), rapeseed/mustard, safflower, jute and copra and Fair & Remunerative Price (FRP) for sugarcane on the basis of the recommendations of the Commission for Agricultural Costs & Prices (CACP), after considering the views of State Governments and Central Ministries/ Departments concerned and other relevant factors. In addition, MSP for toria and de-husked coconut are also fixed on the basis of MSPs of rapeseed/mustard and copra, respectively.

The information regarding MSPs fixed for the 22 mandated agricultural crops for the year 2022-23 and 2023-24 as on 3/11/2023 has been provided as Annexure, enclosed herewith.
