The undersigned is directed to refer to Economic and Statistics Division's Office Memorandum No. 6-3/2024-MSP-ES dated 01.01.2025 conveying the decision of Government of India for fixing Minimum Support Price (MSP) for FAQ variety of Milling Copra at Rs. 11582/- per quintal for 2025 crop season.

- 2. It has been decided with the approval of the Competent Authority to fix the MSP for mature de-husked coconut at the rate of Rs. 3130/- per quintal for the crop season 2025 based on the MSP of FAQ variety of Milling Copra for 2025 season.

The Government has approved Price Policy for Copra for 2025 season and the following decisions have been taken in this regard:

- (i) The Minimum Support Price (MSP) of Fair Average Quality (FAQ) of Milling Copra and Ball Copra has been fixed at ₹11,582/- per quintal and ₹12,100/per quintal respectively, for 2025 season.
- (ii) Based on the MSP of FAQ variety of Milling Copra, the Department of Agriculture & Farmers Welfare will fix the MSP of mature De-Husked Coconut for 2025 season.
- (iii) The National Agricultural Cooperative Marketing Federation of India Ltd. (NAFED) and National Cooperative Consumers' Federation (NCCF) will be the Central Nodal Agencies (CNAs) for procurement of Copra and De-Husked Coconut under Price Support Scheme (PSS). Accordingly, these agencies will suitably engage State agencies for procurement operations
