Copra and Ball Copra has been fixed at ₹11,582/- per quintal and ₹12,100/-

per quintal respectively, for 2025 season.

(ii) Based on the MSP of FAQ variety of Milling Copra, the Department of

Agriculture & Farmers Welfare will fix the MSP of mature De-Husked Coconut

for 2025 season.

The Government of India has approved the Price Policy for Raw Jute for 2025-26 Season and the following decisions have been taken in this regard:

- (i) The Minimum Support Price of Raw Jute (TD-3 grade) has been fixed at ₹ 5650/per quintal for 2025-26 Season.
- (ii) Based on MSP of Raw Jute (TD-3 grade), corresponding MSP for other varieties and grades of Raw jute will be fixed by the Ministry of Textiles while taking into account the aggregate scores assigned to different grades of Raw jute, apart from normal market price differentials.
- (iii) The Jute Corporation of India (JCI) will continue as Central Nodal Agency to undertake Price Support Operations. The losses incurred, if any, in such operations, will be fully reimbursed by the Government as per guidelines.
